

## Terms and Conditions

Participation in the Philips Avent Campaign – Up to 20% discount promotion (“**Promotion**”) is deemed to be in acceptance of the terms and conditions herein (these “**Terms and Conditions**”).

### Promoter

1. The promoter for the Promotion is Philips Electronics Pte Ltd of 622 Lorong 1, Toa Payoh, Singapore 319763 (“**Promoter**”).

### Promotional Period

2. The Promotion commences at 12am SGT on 22<sup>nd</sup> November 2019 and ends 11:59pm SGT on 31<sup>st</sup> December 2019 (“**Promotional Period**”). The duration of the Promotional Period shall not be extended except as notified by the Promoter.

### Eligibility and Participation

3. The Private Sale is open to all members of Philips Online Shop who have active accounts set up on [www.philips.com.sg](http://www.philips.com.sg). (“**Members**”).

4. **Other discounts/promotions/vouchers, including** Philips Birthday Promotion is not applicable to this Promotion.

5. All items under this Promotion are on a while stocks last basis. Items sold under this Promotion are not exchangeable and non-refundable.

(Collectively referred to as “**Eligible Philips Products**” and each an “**Eligible Philips Product**”).

The Promoter reserves the right to validate and check the authenticity of the order and to disqualify any Customer for tampering with the order process, or who submits an order that is not in accordance with these Terms and Conditions and Philips General Ts&Cs. Breach of these Terms and Conditions and Philips General Ts&Cs will render any discount provided by the Promotion Code(s) void and the cancellation of such order(s).

13. These Terms and Conditions may be amended by the Promoter at its discretion. All visuals are for illustration purposes only.

The Promoter reserves the right to modify or cancel any order or revoke the use of any Promotion Code(s) for any reason including suspicious or fraudulent activities, misuse of the Promotion Code(s) or breach of these Terms and Conditions, without incurring any liability. The decision as to the right to use of the Promotion Code(s) will be at the complete discretion of the Promoter and no correspondence will be entered into.

15. The Promoter accepts no responsibility for any variation in price of the Eligible Philips Product(s) from other suppliers.

16. Any tax liability arising as a result of purchasing any Eligible Philips Product(s) is the responsibility of the Customer.

If for any reason this Promotion is not capable of running as planned, including without limitation, infection by computer virus, bugs, tampering, unauthorised intervention, fraud, technical failures or any other causes beyond the control of the Promoter which corrupt or affect the administration security, fairness, integrity or proper conduct of this Promotion, the Promoter reserves the right in its sole discretion to disqualify any individual who tampers with the process, and/or to cancel, terminate, modify or suspend the Promotion. The Promoter assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorised access to, or alteration in relation to the Promotion.

The Promoter is not responsible for any problems or technical malfunction of any telephone network or lines, computer online systems, servers or providers, computer equipment, software, failure of any email to be received by the Promoter on account of technical problems or traffic congestion on the Internet or at any website, or any combination thereof, including any injury or damage to Customer's or any other person's computer related to or resulting from participation or downloading any materials in this Promotion.

Except for any liability that cannot by law be excluded, the Promoter and Koninklijke Philips Electronics N.V ("**Philips**") (including their respective officers, affiliated companies, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion.

26. These Terms and Conditions constitute the entire agreement of the parties relating to the participation and the conduct of the Promotion.
